Council Member Linde introduced the following resolution and moved for its adoption:

RESOLUTION NO. 2006-04**

RESOLUTION ACCEPTING BIDS

WHEREAS: pursuant to an advertisement for bids for the improvement of the following streets/avenues:

Concrete Replacement Project
3rd Street/CSAH 32

Concrete Reconstruction (Section A)
10th Avenue SW and 4th Street SW
Circle Drive

Bituminous Reconstruction (Section B)
3rd Avenue SE (5th Street SE to 4th Street SE)
4th Street SE (3rd Avenue SW to 1st Avenue SE)
7th Street SE (4th Avenue SE to 3rd Avenue SE)

Bituminous Overlay (Section B)
North Broadway (Hwy 109 to 5th Street NW)
3rd Street NW (5th Avenue NW to 6th Avenue NW)
Half Moon Road (Hwy 109 to 6th Avenue SW)

Bids were received, opened and tabulated according to law, and the following bids were received complying with the advertisement:

AND WHEREAS, it appears that Hoffman Concrete Inc. of Mankato, MN is the lowest responsible bidder for the Concrete Replacement project and Section A of the 2006 Street Improvement project, and Southern Minnesota Construction (SMC) of Mankato, MN is the lowest responsible bidder for Section B (bituminous projects).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WELLS, MINNESOTA:

1. The Mayor and clerk are hereby authorized and directed to enter into a contract with Hoffman Concrete, Inc. of Mankato, MN in the name of the City of Wells for the improvement of 10th Avenue SW, 4th Street SW and Circle Drive. The mayor and clerk are also hereby authorized to enter into a contract with Southern Minnesota Construction (SMC) of Mankato, MN in the name of the City of Wells for the improvement of 3rd Avenue SE (5th Street SE to 4th Street SE), 4th Street SE (3rd Avenue SW to 1st Avenue SE), 7th Street SE (4th Avenue SE to 3rd Avenue SE) as well as providing bituminous product to the City of Wells for various overlay projects, according to the contract form, plans and specifications therefore approved by the city council and on file in the office of the city clerk.
2. The city clerk is hereby authorized and directed to return forthwith to all bidders the deposits made with their bids, except that the deposits of the successful bidder and the next lowest bidder shall be retained until a contract has been signed.

The motion for the adoption of the foregoing resolution was duly seconded by Council Member Carroll and upon vote being taken thereon, the following voted in favor:


Whereupon said resolution was declared duly passed and adopted by the City Council of the City of Wells on April 10, 2006.
