Council Member Braun introduced the following resolution and moved for its adoption:

CITY OF WELLS RESOLUTION NO. 2015-13

A RESOLUTION CLARIFYING THE GOLF CART ORDINANCE

WHEREAS, on October 10, 2009, the City of Wells approved Title VII, Chapter 70, Traffic Code §70.71 DRIVING, OPERATING OR CONTROL OF MOTOROIZED GOLF CARTS stating a motorized golf cart may be driven, operated or controlled on the roadways or shoulders of roadways under the jurisdiction of the City of Wells (not those under the jurisdiction of Faribault County or the State of Minnesota), except such roadways prohibited by resolution of the City Council and only in strict compliance with this subchapter; and

WHEREAS, the City Council would like to clarify which streets, roadways and other city areas GOLF CARTS ARE NOT PERMITTED:

- (A) MN Hwy 22;
- (B) MN Hwy 109;
- (C) Broadway from 7th Street SW north to 2nd Street NE (mostly CSAH 61);
- (D) Franklin Street from South Broadway to MN 22/2nd Ave NW (CSAH 61);
- (E) 2nd Avenue NW north from MN 109/22 intersection (CSAH 29);
- (F) 2nd Street NW east from MN 22/2nd Ave NW to dead-end (CSAH 62);
- (G) 2nd Avenue NE south from 2nd Street NW to 1st Street NE (CSAH 62);
- (H) 1st Street NE east from 2nd Avenue NE to MN 109 (CSAH 62);
- (I) 1st Street NE east from 109 to City Limit (CSAH 32);
- (J) 3rd Street SW east from 3rd Avenue SW to Broadway then 3rd Street SE east from Broadway to MN 109 (CSAH 60);
- (K) Public alleys except to enter/exit garage/storage shed owned by golf cart owner;
- (L) St. Casimir Cemetery;
- (M) Rosehill Cemetery;
- (N) Half-Moon Park (except for Kernel Days)

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WELLS, that Title VII, Chapter 70, Traffic Code §70.71 DRIVING, OPERATING OR CONTROL OF MOTOROIZED GOLF CARTS is clarified and golf carts are not permitted on the aforementioned streets, roadways and other city areas.

The motion for the adoption of the foregoing resolution was duly seconded by Council Member Burns and upon vote being taken thereon, the following voted in favor:

Whereupon said resolution was declared duly passed and adopted by the City Council of the City of Wells, on April 27, 2015.


